RESIDENTIAL HIGH-EFFICIENCY WATER HEATER REBATE

QUALIFICATIONS

The qualifying equipment must be installed in a Minnesota home served with natural gas from CenterPoint Energy between January 1, and December 30, 2011. The qualifying equipment must meet the following efficiencies or requirements: Rebate offer applies only to new natural gas water heaters.

Atmospheric, direct or power vent water heaters (tankless or hybrid models do not qualify)

- .62 EF (\$70 rebate)
- .64 EF (\$85 rebate)
- .67 EF (\$100 rebate)
- Indirect water heater installed with 91% AFUE or greater condensing boiler (\$200 rebate)

CenterPoint Energy references AHRI (Air Conditioning, Heating & Refrigeration Institute) directory to verify the energy factor of the water heater.

Dealers/Plumbers are not eligible to receive their customer's rebate.

Building contractors should negotiate with homeowners to determine who receives the rebate.

Equipment installed under warranty replacement does not qualify for the rebate.

APPLICATION REQUIREMENTS

The rebate application form must be submitted within 90 days of installation date or postmarked by Dec. 30, 2011 whichever comes first. Application must be completely filled out with purchaser information, equipment information (including brand, complete model number, serial number, installation date and Energy Factor) and dealer/plumber or retailer information. CenterPoint Energy is unable to accept applications that do not include all this information. A copy of the dated invoice or sales receipt must accompany completed rebate application. The invoice or sales receipt must include the following information: brand and complete model number. It is the responsibility of the purchaser to ensure that the installed equipment qualifies for the rebate. If it does not qualify, no rebate will be paid.

CenterPoint Energy reserves the right to inspect the installed equipment.

Rebate qualifications and amounts are subject to change. Rebate funds are limited. Completed rebate forms will be processed in the order in which they are received. CenterPoint Energy CIP rebate programs may be cancelled or changed at any time.

This program ends Dec. 30, 2011.

The rebate application form must be postmarked by Dec. 30, 2011 to be considered for rebate. Rebates will not be paid if funds are depleted prior to Dec. 30, 2011.

REBATE DETAILS

Rebate amounts will be issued for equipment installed between Jan. 1, 2011 and Dec. 30, 2011 only. Qualifying equipment installed on December 31, 2011 will be eligible for our 2012 rebate offering. CenterPoint Energy issues cash rebates in the form of checks, not utility bill credits. CenterPoint Energy is not responsible if the dealer/plumber or retailer does not provide accurate information about the amount of rebate or equipment eligibility. Rebate checks will be mailed within 6-8 weeks.
