

RESIDENTIAL HIGH-EFFICIENCY WATER HEATER REBATE

QUALIFICATIONS

The qualifying equipment must be installed in a Minnesota home served with natural gas from CenterPoint Energy. The qualifying equipment must meet the following efficiencies:

Atmospheric, direct or power vent water heaters

- .62 EF (\$50 rebate)
- .64 EF (\$75 rebate)

Tankless or instantaneous models do not qualify for the rebate.

CenterPoint Energy uses GAMA (Gas Appliance Manufacturers Association) listings to determine the efficiency of the equipment. You can access this information at www.gamanet.org

Dealers/Plumbers are not eligible to receive their customer's rebate.

Building contractors should negotiate with homeowners to determine who receives the rebate.

Equipment installed under warranty replacement does not qualify for the rebate.

APPLICATION REQUIREMENTS

The rebate application form must be submitted within 90 days of installation date or postmarked by December 31, 2008 whichever comes first. Application must be completely filled out with purchaser information, equipment information (including brand, complete model number, serial number, installation date and Energy Factor) and dealer/plumber or retailer information. **CenterPoint Energy is unable to accept applications that do not include all of this information.** A copy of the dated invoice or sales receipt must accompany completed rebate application. The invoice or sales receipt must include the following information: brand and complete model number. It is the responsibility of the purchaser to ensure that the installed equipment qualifies for the rebate. If it does not qualify, no rebate will be paid.

CenterPoint Energy reserves the right to inspect the installed equipment.

Rebate qualifications and amounts are subject to change. Rebate funds are limited. Completed rebate forms will be processed in the order in which they are received. CenterPoint Energy CIP rebate programs may be cancelled or changed at any time.

This program ends Dec. 31, 2008.

The rebate application form must be postmarked by Dec. 31, 2008 to be considered for rebate. Rebates will not be paid if funds are depleted prior to Dec. 31, 2008.

REBATE DETAILS

Rebate amounts will be issued for equipment installed between Jan. 1, 2008 and Dec. 31, 2008 only. CenterPoint Energy issues cash rebates in the form of checks, not utility bill credits. CenterPoint Energy is not responsible if the dealer/plumber or retailer does not provide accurate information about the amount of rebate or equipment eligibility.
